NOTICE OF FUNDING AVAILABILITY

The City of Coconut Creek announces the availability of approximately \$67,690 for Housing Rehabilitation with funding through the State Housing Initiatives Partnership (SHIP) Program. SHIP home rehabilitation funds are available for **extremely-low, very-low, low, and moderate income households up to 120% AMI**, with priority given to special needs households. The City of Coconut Creek announces the availability of approximately \$56,900 for Housing Rehabilitation through the HOME Investment Partnerships (HOME) Program. HOME rehabilitation funds are available for **extremely-low, very-low, and low-income households up to 80% AMI**, with priority given to special needs households (see income chart below). The City of Coconut Creek announces the availability of approximately \$193,852 for Purchase Assistance with funding through the Community Development Block Grant (CDBG) Program. Purchase assistance funds are available for **extremely-low, very-low, and low-income households up to 80% AMI**, with priority given to special needs households (see income chart below).

Purchase Assistance Applicants MUST attend a MANDATORY "Homeownership Counseling Workshop" prior to receiving assistance.

Applications will be available beginning Wednesday, September 12, 2018, until all funds are committed. Applications will be accepted on a first come, first qualified, first served basis, by appointment only per the instructions on the program application.

HOME funds available to very low and low income households up to 80% AMI. SHIP funds available to very low, low and moderate households up to 120% AMI. 


